**4. RENT INFORMATION AND CANCELLATIONS**

A cost of **\$50.00/market** will be due at the beginning of your season. We accept pre-payment for the month or the entire season (17 markets from June 6 to September 26). Your payment should be processed at our Administration Office on the 2nd floor of the Net Loft building located next to the Farmers Market. We accept cash, debit, Visa, MasterCard, American Express and personal cheques. All cheques must be payable to "Canada Mortgage and Housing Corporation" or "CMHC". Please contact a **Tenant Coordinator** to arrange pre-payment.

Cancellations must be made 24 hours prior to the beginning of the market to receive a 50% refund (if applicable); cancellations made within 24 hours will not receive a refund.

**5. INSURANCE**

All liquor vendors on Granville Island must carry Third Party Liability Insurance (coverage minimum \$2 million). The policy must list Canada Mortgage and Housing Corporation (CMHC) as additional insured:

**6. GENERAL REQUIREMENTS FOR LIQUOR VENDORS**

Liquor vendors must comply with all LCLB policies and be licenced manufacturers with an on-site store endorsement. Please provide us with your Farmer's Market Authorization from the LCLB. Vendors may apply for Farmer's Market Authorization through One Stop (<http://www.bcbusinessregistry.ca/>). Please note that Granville Island and CMHC are included as an eligible market in LCLB Policy Directive 15-11 (Oct. 2, 2015). As a federal crown corporation, CMHC does not have a business or society number.

All servers on site must possess Serving It Right and must be able to produce their certificate number if requested to do so.

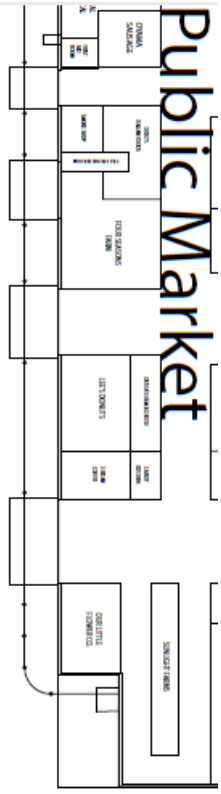

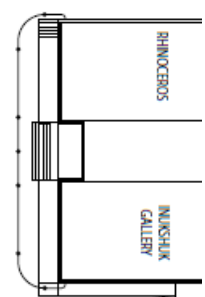
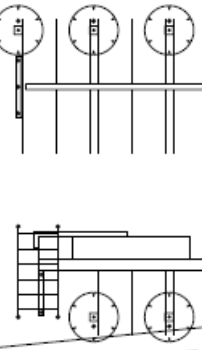
